Among these, the MAT-S adheres to EN ISO 10524-2:2019, which specifies design, materials, and construction requirements for pressure regulators used with medical gas on manifold and line pressure regulators. This ensures superior reliability and safety in medical gas supply management.

The MAT-S remains the benchmark in **Performance & Efficiency**, it continues to set the standard in manifold technology with its proven dome-bias regulator design, reducing connections to minimize leak risks while ensuring superior reliability. A lightweight, corrosion-resistant cover extends its lifespan, and low change-over pressures (10.4 bar for 4.0 bar manifolds, 20.0 bar for 8.0 and 11.0 bar versions) optimize gas utilization, increasing uptime and reducing costs. Its serviceable regulators lower maintenance expenses, and individual service valves enable uninterrupted gas supply during servicing.
